- (e) To purchase and donate properties and to render financial assistance to any institution or association or scholars to further educational or academic pursuits.
- (f) To afford relief to the poor in distress and poverty establishment and maintain educational institution and workshops for imparting general, technical professional education.
- (g) To make grants by way of scholarships financial assistance for the benefit or deserving students, scholars and
- (h) To encourage students in their studies and constitute prizes shields and endowments for their improvements.

III. VESTING OF THE PROPERTIES OF THE TRUST

The properties of the Trust shall be

V. ADMINISTRATION

- (k) To invest all necessary expenses in connection with the Trust and its management.
- (l) To accept contributions, donations, gifts, regencies or grants to the trust from any person or persons and to hold the same upon trust and subject to the powers, provisions and stipulations contained in the DEED OF TRUST.

- (r) To deposit, invest, withdraw, purchase, sell mortgage redeem, convey, consolidate, subdivide renew or otherwise deal with the securities or other assets, movable or immovable held and owned by the Trust.
- (s) To receive gifts, purchase, sell, mortgage, assign, surrender, lease and exchange the movables or immovable properties owned by the Trust.
- (t) To appoint committees, local committees, sub committees adhoc committees or other committees for any other purpose as and when required constant with the aims and objects of the Trust.

VII. MINUTES, ACCOUNTS AND AUDIT

VIII. POWER TO ALTER RULES AND REGULATIONS

XI. THE MANAGING TRUSTEES AND ITS RELATIVES NOT TO BENEFIT

Notwithstanding powers vested with the managing trustees under the proceeding clauses no part of the income of the trust shall be utilized directly or indirectly for the benefit of the managing Trustees, member Trustees or any other persons who makes a substantial contribution. XII. NO REMUNERATION TO THE TRUSTEES

- (p) To establish schools, colleges, hostels and other institutions to give effect to the aims and objects of the Trust and to manage the same.
- (q) To take over the management of schools, colleges, hostels and charitable Panchayats, or other state or central organizations and other organizations or individuals, or under directions from courts and to maintain the same for effecting the purpose of the trust and also institute scholarships and studentships for students prosecuting their studies in schools, colleges and institutions.
- (r) To deposit, invest, withdraw, purchase, sell mortgage redeem, convey, consolidate, subdivide renew or otherwise deal with securities or other assets, movables or immovable held and owned by the Trust.
