**ORDER**

In the G.O 1<sup>st</sup> cited orders have been issued for Conferment of Minority Status to Educational Institutions through BC, MBC & MW Department and to constitute an Empowered Committee. The Director of Minorities Welfare is the Nodal Officer. It is also ordered that once the applications are duly approved by the Empowered Committee, the Director of Minorities Welfare shall issue Minority Status Certificate to the Educational Institutions.

In the reference 2<sup>nd</sup> cited Annai College of Arts & Science, Thanjavur run by K.K.O. Mohamed Ibrahim Educational and charitable Trust has applied for Renewal of Minority Status (Religious- Muslim)

In G.O. (Ms) No.128, Higher Education (E1) Department, dated 30.04.2021 orders have been issued for renewal of conferment of Religious- Muslim Minority Status for the Academic Year from 2016-17 to 2020-21.

In the letter 3<sup>rd</sup> cited the Director of Collegiate Education has recommended for renewal of conferment of Minority Status (Religious- Muslim) to the Annai College of Arts & Science, Thanjavur run by K.K.O. Mohamed Ibrahim Educational and charitable Trust.

The application of Annai College of Arts & Science, Thanjavur run by K.K.O. Mohamed Ibrahim Educational and charitable Trust was placed before the Empowered committee. The Empowered committee has approved the application of the above mentioned institution in its meeting held on 02.08.2023 based on the report of the Director of Collegiate Education. As approved by the Empowered committee the

Minority Status is granted to Annai College of Arts & Science, Thanjavur run by K.K.O. Mohamed Ibrahim Educational and charitable Trust is renewed for a period of five years from the academic year 2023-2024 subject to the ultimate guidelines that are to be laid down by the Regular Bench of Hon'ble Supreme Court of India based on in "Indicia" for treating an educational institution as a minority institution, and subject to the following conditions.

- 1 The institution should subserve the interest of the minority community (Religious- Muslim)
- 2 To fulfill all the guidelines/ Criteria mandated by the Government.
- 3 Any change in the constitution of the Trust and Managing Trustees should be intimated to the Director of Collegiate Education and Director of Minorities Welfare within a month.
- 4 The institution should provide the details of students admitted every year to the Director of Collegiate Education and Director of Minorities Welfare.
- 5 If any commission or omission of any action does anything against the minority status, the Head of Department shall bring it to the notice of the Government for the withdrawal of minority status and the Government may take further necessary action for the withdrawal of minority status after giving an opportunity to the institution concerned.
